## **Application Procedure for Direct Debit / Autopay Facility**

- Principal cardholders are required to apply to pay their monthly statement by autopay with a bank account in Hong Kong.
- Attached is the Direct Debit Authorization Form, which must be fully completed for the Autopay facility to be accepted by the Bank.
- All details **MUST BE** clearly printed, preferably in block letters.
- A monthly payment limit may be set, any amounts exceeding this limit are required to settle by other means of payment method.
- The box marked "Debtor's Reference" (compulsory field) must be completed with your Club Membership account number. For example, if your number is A000XXX the debtor's reference will be A000XXX.
- If you are a tenant, the "Expiry date" should be the same as the expiry date of your tenancy agreement at the same address.
- Completed application forms should be returned to the Bank for processing. Once the application has been accepted by the bank, the Club will be notified that the Autopay facility is approved. As soon as the Club has received such confirmation, you will be notified by the Club as to the date the first Autopay payment will be made. Until such notification is received, the monthly statements should be settled by other means of payment method.
- Auto-payments are collected on the date indicated on the footnote of the statement (usually on the 18<sup>th</sup> of each month). Queries relating to the club statement should be made prior to that date.

- 若閣下為租客,則「自動轉賬到期」期限將不得超越閣下之「租約到期」期限。
- 填妥之申請表可交還閣下所填寫之銀行審核,一經接納,本會將發信通知閣下自動轉賬生效月份。 在收到通知前,閣下仍需以其他付款方式繳交本會月結單費用。
- ◆ 所有自動轉賬一般會於每月之 18 號過數,如有疑問請於該日期前提出。
